DIRECTIONS FOR USE:

Crop	Rate of Application (Dilution in water)	Critical Comments
Chrysanthemums	3 g/L	For branched pot plants, spray foliage 2 weeks after pinching. For single stem plants, spray 4 weeks after pinching.
Poinsettias: To produce 40 cm plants To produce shorter plants	3 g/L 6 g/L	For single stem and pinched plants. Plants should be turgid. Spray late afternoon.
Azaleas	4.5 g/L	For compact prolific flowering plants, spray 2-3 weeks after final shaping.
Gardenia	6 g/L	For compact plants with more buds, spray when 2/3 final marketing size.
Bedding plants: Petunias, Marigolds, Zinnias, Asters, Cosmos, Salvia.	6 g/L	To form more compact plants and hold seedlings longer in trays. Spray petunias at 4-6 leaf stage. Spray other plants when first rapid upward growth begins.

GENERAL INSTRUCTIONS:

Mixing:

Add the required amount of Alar to the water in the spray tank under agitation.

Wetting Agent

In all cases, the addition of 600 g/L non-ionic wetting and spreading agent at 10 mL per 100 litres of spray is recommended.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT:

DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

STORAGE AND DISPOSAL:

Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight and away from children, animals, food, feedstuffs, seed and fertilisers.

Rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on-site. Dispose of at a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.
